

2012-2013 Kindergarten Application Procedures

Dear Parents,

Thank you for your interest in Queen of Apostles School. We are proud to offer a quality Catholic education through the dedication of a very effective faculty and staff. If you would like to meet with me to familiarize yourself with our program and how we can meet your child's needs, please call for an appointment. Our school open house will be on January 31, 2012.

Applications will be accepted beginning Monday, January 9, 2012. To guarantee that your child will be included in the **February 11th screening** of kindergarten applicants, we must have his/her application by **February 9, 2012**. Applications received after that date will be kept on file and we will contact you if a subsequent screening is scheduled.

Please follow the procedures below so we may process your file:

1. Fill out the attached application form completely (please date and sign) and return it with copies of the following:
 - A recent photo of your child (for identification purposes).
 - Completed Supporting Family Application (form attached) - if applicable.
 - Birth Certificate.
 - Baptismal Certificate (if child received the sacrament).
 - Report Card and/or Progress Reports from preschool.
 - Immunization Record.
 - Completed NCEA Survey (form attached).
 - Completed Religious Education Questionnaire (form attached).
2. California require any child that enter Kindergarten must turn 5 before November 2.
3. Please include a **non-refundable** application/testing fee of \$100.00 (per application).
4. Please ask your child's current teacher to fill out the enclosed **Kindergarten Assessment Form** and return it to Queen of Apostles School. The school's address is printed on the bottom of the assessment form.
5. Attached is a list of the California immunization requirements for school entry and a Report of Health Examination form. You will need to make an appointment (after March 1) for your child's health exam, TB test, and any necessary immunizations. Please have your doctor's office complete the Health Examination form at this time and submit it to us before the first day of school.
6. **You may visit classrooms and attend our school open house on Tuesday, January 31, 2012.** We hope that all perspective families will be able to attend. Please refer to the attached sheet for further information.
7. Our kindergarten screening will be on **Saturday, February 11, 2012**. We will notify you of the time scheduled for your child's screening in advance. You will be advised of the results and placement as soon as possible after your child's screening.
8. If your child is accepted and we have space available, you will be given registration papers to fill out and return, as well as further information about our school. At this time, a non-refundable registration fee is requested. (The registration fee for the 2011/2012 school year was \$625.00, but this fee for the 2012/2013 school year has not been finalized.)
